

- Gefahrstoffe/Umweltmedizin z.B. Schimmelpilze in Schulen, Klimakrise
- Jugendzahnärztlicher Dienst z.B. Kariesprophylaxe
- Humanitäre Sprechstunde z.B. Flüchtlinge/ Migranten
- Prävention z.B. gesundheitliche Aufklärung, Impfsprechstunde
- Öffentlichkeitsarbeit/Social Media, z.B. Merkblätter Zecken

# Tasks of public health authorities

**Infection control** e.g. EHEC, Corona pandemic

**Municipal hygiene** e.g. germs in drinking water

**Disaster management**

**Official medical examination** e.g. civil service employment

**Child health** e.g. school enrollment examination

**Community psychiatry** e.g. compulsory admissions

**Environmental health** e.g. mold in schools, climate crisis

**Dental service** e.g. caries prophylaxis

**Humanitarian medicine** e.g. refugees/ migrants

**Preventive medicine** e.g. health education, [vaccination consultations](#) **Health communication**, e.g. leaflets on ticks, social media

# Legislation

- Vorrang des Gesetzes (within remits of the law)

“Die Gesetzgebung ist an die verfassungsmäßige Ordnung, die vollziehende Gewalt und die Rechtsprechung sind an Gesetz und Recht gebunden” (Art 20 (3) GG).

## Practise: are we doing legal things

- Vorbehalt des Gesetzes (legal basis)

*(1) Soweit nach diesem Grundgesetz ein Grundrecht durch Gesetz oder auf Grund eines Gesetzes eingeschränkt werden kann, muß das Gesetz allgemein und nicht nur für den Einzelfall gelten. (Art 19 (1)1 GG „Verbots des Einzelfallgesetzes ausgeschlossen)*

# Lessons learned: Vaccination Center

## NEW EVERYTHING

- Learning on the job
  - **Staff** (e.g. retired MDs, Lufthansa air crews...)
- New IT, data transfer
- Analysis changing (weekly)
- Data security (unchartered territory)
- Vaccine logistics (outside regular channels & scale)





# MPX - again?

Old vaccine – new disease

- Who orders? How much? Who pays?
- clarification over time
- Purchase: federal organisation, locally NO influence
- Communication: on your own

pop >750.000 + 750.000 commuting/daily

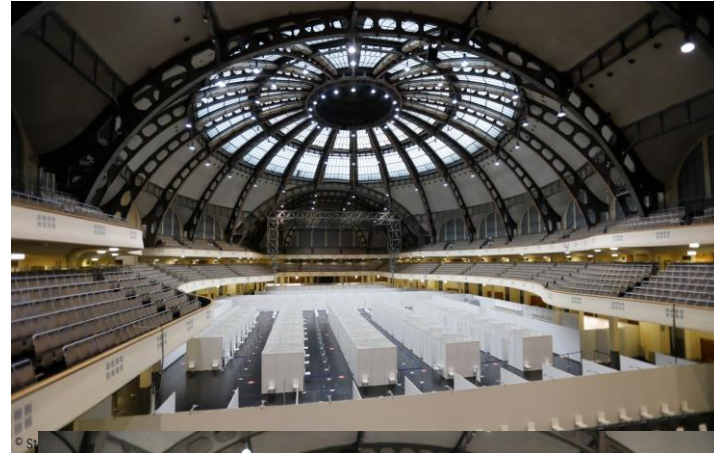
largest airport, max 250.000/day
